Discussion Topics: This course will be held in the Evening at Burnaby Campus.

This course offers a theoretical and thematic exploration of the connections between the global and the local. The history and trajectory of societies involve specific configurations of social class, gender, and ethnic relations. These take shape within and help shape the character of the global system in different historical periods. The course focuses on the following themes of political, economic, and cultural transformation:

- 1- What is the state?: from the national to the global era;
- 2- Capital and classes: contending world historical projects;
- 3- Development discourse
- 4- Alternatives to Euro-American centrism: shared and contested quests for meaning.

Through a program of focussed readings, critical analysis, in-depth class discussion, case studies, thoughtful synthesis, historical investigation, and film materials, we will examine the material aspects of cooperation and coercion, class relations in structures of capital accumulation and global governance, and cultural dynamics. Alternatives to Euro-American centrism are explored through the examples of citizenship, cultural politics, ethnic and religious conflicts, human rights, indigenous rights, and womenis rights. Throughout, the course addresses historical and global dimensions of classical and contemporary theory, and develops an alternative framework to postmodernist criticisms.

- 4- Presenting the international news of the week 5%
